



## 2026 STATEWIDE GENERAL ELECTION CANDIDATE FILING

Candidate filing will occur at the **Durham County Board of Elections**, located at 3825 S. Roxboro Street, Suite 101, Durham, NC 27713. Candidates may file during regular business hours (8:30 a.m. – 5:00 p.m.), except on the first day of the filing period.

### FILING PERIOD



- The filing period begins on Monday, June 8, 2026, at 12:00 p.m. and ends on Monday, July 6, 2026, at 5:00 p.m.
- **Note:** Our office will be closed and filing will be paused on Friday, June 19, 2026, in observance of Juneteenth, and on Friday, July 3, 2026, in observance of Independence Day.

### REQUIREMENTS



- Must meet residency, age, and supplemental requirements for the office sought.
- Pay the filing fee by cash, check or money order at the time of filing. A check or money order must be made out to Durham County Government.

### FILING



- Candidate filing can be completed **in person or by mail**.
- The Notice of Candidacy Form will be completed, and a brief overview of campaign finance requirements will be provided during in-person filing.
- Forms must be fully completed and notarized if the submission is by mail.

### CAMPAIGN FINANCE



- Campaign finance paperwork must be submitted within **10 days** of any of the following: filing for office, making a public declaration of intent, receiving contributions, or making expenditures towards the campaign.
- It is common for the 10-day period to begin at filing, but it may begin earlier depending on campaign activity.

## 2026 OFFICE QUALIFICATION REQUIREMENTS

- Must be at least 21 years of age.
- Must be a registered voter in the county.
- Must be a registered voter in the municipality (for applicable offices).
- Must reside in the district (for applicable offices).

## 2026 CAMPAIGN FINANCE REPORTING INFORMATION

**Congratulations on filing for office!** Below are key reminders and essential information on Campaign Finance Reporting. Please access the QR Codes with your phone camera or type the addresses into your web browser for more detailed information. Web addresses are case-sensitive.



Treasurers must attend training within 90 days of appointment and once every four years after the initial training.



If you have not started your committee, please submit the required organizational paperwork to the Board of Elections no later than **10 days** from the date of filing for office OR receiving contributions or making expenditures for the office sought. The organizational packet is in the right pocket of the blue candidate folder.
